Auditing the Real Estate and the Real Asset Portfolio (Real Assets) at your organization can be very difficult due to the complexities and differences in real asset investments compared to other investments. Every investment sector in your company's portfolio has its share of jargon and acronyms — but the real assets investment class would probably take the award for the most complicated. Given current market conditions, the increased volume of investments into real assets and the higher interest rate market — auditing Real Assets can be very intimidating. In this session, we will discuss the current state of the Real Asset market and highlight some of these challenges and discuss how to audit through them.

This session will compare current public pension fund auditing trends with prior auditing techniques learned over a 35-year career. The speaker will also ask conference attendees to describe some newer audit techniques.



This session will discuss the obstacles of and formation of the Association of Public Pension Fund Auditors in 1991. Participants are expected to come away with a better understanding of how pension fund internal audits, operations and administrative procedures were performed around the time APPFA was formed.

2a. Lessons Learned from the Dixon, Illinois Municipal Fraud, 8:40 – 10:00 AM

Multiple perspectives of the largest U.S. municipal fraud to date will be presented to show the lessons learned and outcomes that have affected various stakeholder groups. The undiscovered fraud spanned over two decades. How could the accumulated theft of more than \$53 million occur in a town with an annual budget at the time of discovery of just over \$20 million?

Topics discussed will include a background of the motivations and seemingly perfect storm of events that led to the fraud and the discovery, the necessity of internal controls, and implications for those in the roles of governance and audit.

Join us for a discussion on how to strengthen your organization's security posture by fostering a collaborative relationship between Internal Audit, Information Security, and outside partners such as those provided by the Department of Homeland Security's (DHS) Cybersecurity & Infrastructure Security Agency (CISA).

This session will highlight a collaborative effort between IL TRS' two internal departments and how a Federal partner can provide guidance for State agencies. Information Security, implements the organization's security framework, identifies risks, selects, and implements mitigating controls. Then Internal Audit reviews the controls and mitigations, verifying these controls operate in the manner that is stated and reasonable. Auditing the controls and mitigations shouldn't be the only collaboration point. After the audit is completed, Internal Audit can help bridge the gap between Security, Information Technology, Executive Staff, and the Board of Trustees to help foster a culture of security awareness for the entire organization and drive a greater level of assurance between all stakeholders.

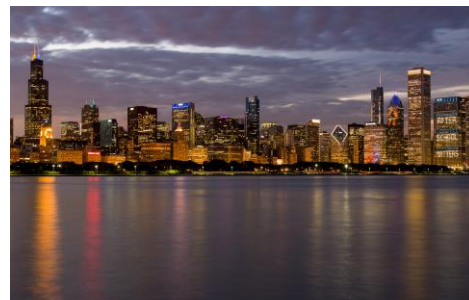

Transportation

O'Hare International Airport and Chicago Midway International Airport are two common airports that provide airfare transportation. The hotel does not have a shuttle to or from either of the airports. About Your Sponsors and Continuing Professional Education

The Conference APP was referenced earlier in this brochure. This section will explain just a bit more. The Rdmobile/Eventsential APP will be used during the conference. This app can be found in the Apple App Store, Google Play Store, and on your Windows laptop through a link supplied prior to the conference.

The email used for your APPFA registration will be the email that is used to link your account to the Rdmobile/Eventsential account. All users must have and be logged into their Rdmobile/Eventsential account during the conference to perform check-ins while accessing the APPFA event materials.
