The IIASB released the new Global Internal Audit Standards effective January 2025. Our speaker for this session was the chairman of the IIASB during this historic period and will share information and perspectives on the IPPF project and comments on the new Standards. Conference APP

The Conference APP was referenced earlier in this brochure. This section will explain just a bit more. The Rdmobile/Eventsential APP will be used during the conference. This app can be found in the Apple App Store, Google Play Store, and on your Windows laptop through a link supplied prior to the conference.

The email used for your APPFA registration will be the email that is used to link your account to the Rdmobile/Eventsential account. All users must have and be logged into their Rdmobile/Eventsential account during the conference to perform check-ins while accessing the APPFA event materials. When signing up or logging in, the Rdmobile/Eventsential account might ask you to verify your identity from the APPFA registration email account. If you will not have access to that email address at the conference, be sure you sign into your Rdmobile/Eventsential APP prior to leaving for the conference to ensure you will have access!
